### TERMS & CONDITIONS

**ELIGIBILITY** - this program offers rebates for purchasing new energy efficient devices.

**DEADLINES** - items must be purchased between January 1, 2019 and December 31, 2019. Applications must be filed by January 31, 2020. HMU reserves the right to change any portion of this program or to end this program at any time without notice.

**QUALIFYING PURCHASES** - programmable thermostats, room air conditioners, ground source heat pump, central air conditioners/air source heat pumps and gas furnaces are eligible for this program. New units must meet all specified energy efficiency requirements.

**REBATE AMOUNTS & PAYMENTS** - rebates will not exceed purchase price. Rebate applications will be processed as they are received. Please allow 4-6 weeks for payment. Annual funds limited. Check with HMU to ensure availability.

**VERIFICATION** - copies of the sales receipt(s) indicating make, model, purchase date, purchase location, quantity and price must accompany rebate application. **Original energy guides must be attached.** Incomplete applications will be returned. Ground Source Heat Pump Rebate requires prior approval.

  - 15 S.E.E.R. -- \$300 -- add'l full ton \$125
  - 16 S.E.E.R. -- \$400 -- add'l full ton \$150
- INSULATION** ..... See weatherization brochure for details -- 60% of the cost, up to \$750
- PROGRAMMABLE THERMOSTAT** ..... One-half (1/2) of the purchase price, up to \$25
- NATURAL GAS FURNACE** .....  95% AFUE -- \$300  ≥ 96% AFUE -- \$350
