TERMS & CONDITIONS OF THE LIGHTING REBATE PROGRAM

<p>ELIGIBILITY: This program offers rebates for installing energy efficient lighting. Customers using HMU as their primary electric source are eligible for rebates. Items must be installed between January 1, 2019 and December 31, 2019. Applications for rebates for products installed in calendar year 2019 must be submitted by January 31, 2020. HMU reserves the right to change any portion of the rebate program, or to end the program entirely, with or without notice and at any time.</p> <p>VERIFICATION: A copy of sales receipt, invoices or similar documentation showing items purchased, date of purchase, purchase location, quantity, price and any applicable Energy Star guides must accompany rebate application. HMU reserves the right to a pre and/or post install inspection before issuing rebate. Project must demonstrate energy savings compared to existing equipment or to standard equipment in order to receive a rebate for new construction.</p> <p>REBATE AMOUNTS AND PAYMENTS: Not all possible installation options can be address via this form. Contact HMU if your lighting project does not fall under the guidelines listed. Rebate amount will not exceed purchase price. Annual funds are limited. Customers are encouraged to contact HMU to verify the program is still in effect and to ensure rebate funds are available before beginning installation. Rebate amounts subject to change at anytime with our without notice. Please allow 4-6 weeks for processing and payment.</p>	<p>Customers whose projected single or combined rebate(s) will exceed \$1,500 in a calendar year should contact HMU before installation to ensure funds are available. Per customer rebates may be limited in any one funding year at the descretion of HMU.</p> <p>QUALIFYING PURCHASES: LED technology must be Energy Star or Design Light Consortium (DLC) qualified. Outdoor lighting does not qualify for rebate.</p> <p>CALCULATE HOURS OF OPERATION OR USE: This helps you determine energy savings and HMU meet our annual reporting requirements. Example: Lights are on from 8:00AM to 4:00PM, Monday through Saturday.
