QUALIFYING PURCHASES - new refrigerators, clothes washers, freezers, dehumidifiers, and dishwashers are eligible for this program. The new appliances must meet all specified energy efficiency requirements.

REBATE AMOUNTS & PAYMENTS - rebates will not exceed purchase price. Rebate applications will be processed as they are received. Please allow 4-6 weeks for payment. Annual funds limited, check with HMU to ensure availability.
