A RESOLUTION TO MODIFY THE ELECTRIC RATES FOR
HARLAN MUNICIPAL UTILITIES

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF HARLAN MUNICIPAL
UTILITIES:

SECTION 1. The electric rates for Harlan Municipal Utilities are hereby modified to reflect the following changes:

Decreasing the following electric rates (usage only) by 3% as listed on the attached rate chart:

All service not otherwise listed; Demand; Residential Electric Heat; Time of Use, Winter and Summer; Water Plant and Street Lights.

SECTION 2. Repealer Clause. All resolutions, parts of resolutions, or service rules conflicted herewith are hereby repealed.

SECTION 3. Severability Clause. If any section, provision, or part of this resolution shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 4. Effective Date. This resolution shall be effective from and after final passage, approval, and publication as provided by law, with the effective billing date of June 1, 2025.
