I agree that I am obligated to pay for utility services and insufficient fund charges in the event that a charge to my account is dishonored, for whatever reason, and the Harlan Municipal Utilities retains its normal collection rights. I acknowledge that that origination of ACH transactions to my account must comply with U.S. Law.

Auto-Pay is a free and convenient payment service for busy people. Auto-Pay is available for your utility and/or telecommunications bills.

Here are some advantages:

No Need to Write a Check: Auto-Pay eliminates the need to write a check for your utility and/or telecommunications bill. Participating customers authorize their financial institution to automatically deduct the amount of their bill from their checking or savings account.

Eliminates Late Payment Penalties: Late payment penalties are a thing of the past, because Auto-Pay remembers for the customer. There is no worry about a payment being lost in the mail or note being sent during a vacation.

Saves Postage: Customers who now mail their bill payments will save the cost of 12 postage stamps each year. It is one less chore to handle and remember every month.
